- 4. We have only traced the disclosures regarding 'Public Shareholding' and 'Promoter and Promoter Group Shareholding' in the Statement from the disclosures made by the Management and are, therefore, not expressing a review opinion thereon.
- 5. Based on our review conducted as above, nothing has come to our attention that causes us to believe that the Statement has not been prepared in all material respects in accordance with the applicable Accounting Standards notified pursuant to the Companies (Accounting Standards) Rules, 2006 as per Section 211(3C) of the Companies Act, 1956 and other recognised accounting practices and policies, and has not disclosed the information required to be disclosed in terms of Clause 41 of the Listing Agreement including the manner in which it is to be disclosed, or that it contains any material misstatement.

The segment revenues, results and assets of the other activities do not constitute reportable segment under Accounting Standard 17 on Segment Reporting and accordingly no disclosure is required.
- 3. The Company follows the intrinsic value method for Employee Stock Option Based Compensation. In respect of options vested during the quarter ended December 31, 2013, had the fair value method been used, the profit after tax for the quarter would be lower by ₹ 18.86 million (Previous quarter ended September 30, 2013 ₹ 21.80 million and corresponding quarter ended December 31, 2012 ₹ 13.59 million) and the EPS (not annualized) for the quarter ended December 31, 2013 would be ₹ 2.78 (Previous quarter ended September 30, 2013 ₹ 2.85 and corresponding quarter ended December 31, 2012 ₹ 2.70).
- 4. The Finance costs primarily include the bank and collection charges paid to banks and payment gateways respectively.
- 5. The exceptional item in the year to date ended December 31, 2013 represents the provision for diminution in the carrying value of investment in Nogle Technologies Pvt. Ltd. The exceptional item in the year ended March 31, 2013 represents the provision for diminution in the carrying value of investment in Ninety Nine Labels Private Limited and waiving off of advance (net) given to Info Edge (India) Mauritius Limited and the loss on sale of debentures held in Ninety Nine Labels Private Limited.
- 6. The inapplicable items in the format of the above results as per Annexure I to Clause 41 of the Listing Agreement have not been disclosed.
- 7. Previous periods/years figures have been regrouped/rearranged to confirm to the current period classification.
